INTRODUCTION

In accordance with [L.R.S. 40:1379.3\(R\)\(2\)](#), the Department of Public Safety and Corrections, Office of State Police is providing the following information as a summation of the Concealed Handgun Permit Unit's 2022 Annual Legislative Report. The following report covers the period of **January 1, 2022**, to **December 31, 2022**, and contains statistical information on the number of permits issued, denied, revoked, or suspended and the reasons for such denial, revocation, or suspension to be categorized by age, sex, race, and zip code.

For the last reporting year, **January 1, 2022**, to **December 31, 2022**, the Department issued **13,595** original five-year concealed handgun permits, **6,367** lifetime permits, and renewed **11,568** permits, for a total of **31,530**. During the same period, the Department denied **1,183** permits, revoked **96** permits, and suspended **323** permits. These statistics are pulled from the Concealed Handguns Permit database and are approximate.

The Louisiana State Police Concealed Handgun Permit Unit was not made aware of any accidents or deaths involving concealed handgun permittees in 2022.

Temporary Permits Issued in 2022

The passage of [Act 465](#) (“**Brandi Trahan Act**”) of the 2016 Regular Legislative Session (**effective August 1, 2016**) enacts R.S. 40:1379.3.2, providing that a person on whose behalf the court has issued a permanent injunction or a protective order to bring about the cessation of abuse and which prohibits the subject of the order from possessing a firearm for the duration of the injunction or protective order may apply to the Deputy Secretary of Public Safety Services of the Department of Public Safety & Corrections (DPS&C) for the issuance of a temporary concealed handgun permit.

The Louisiana State Police Concealed Handgun Permit Unit received only **one (1)** application for a temporary permit in 2022. That application was **DENIED** due to the applicant providing false information on the application.

Reasons for Denial		
L.A.C. 55:I:1307.B.2	187	Applicants shall provide all additional information requested by the department within 10 business days of receipt of the request, unless an extension is granted by the department. If any applicant fails to provide all additional information requested by the department, the application shall be considered incomplete and shall be denied.
L.A.C. 55:I:1307.B.9	2	All applications shall include a properly executed affidavit, provided by the department, whereby the applicant agrees in writing to hold harmless and indemnify the department, the state or any peace officer for any and all liability arising out of the issuance or use of the concealed handgun permit.
L.R.S. 40:1379.3 B.(1)	1	A concealed handgun permit shall be issued only to a Louisiana resident who qualifies for a permit under the provisions of this Section.

L.R.S. 40:1379.3 C.(1)(a)	870	Make sworn application to the deputy secretary of public safety services of the Department of Public Safety and Corrections. The providing of false or misleading information on the application or any documents submitted with the application shall be grounds for the denial or revocation of a concealed handgun permit.
L.R.S. 40:1379.3 C.(6)	42	Not be ineligible to possess a firearm by virtue of having been convicted of a felony.
L.R.S. 40:1379.3 C.(7)	6	Not have been committed, either voluntarily or involuntarily, for the abuse of a controlled dangerous substance, as defined by R.S. 40:961 and 964, or been found guilty of, or entered a plea of guilty or nolo contendere to a misdemeanor under the laws of this state or similar laws of any other state relating to a controlled dangerous substance within a five-year period immediately preceding the date on which the application is submitted, or be presently charged under indictment or a bill of information for such an offense.
L.R.S. 40:1379.3 C.(8)	9	Not chronically and habitually use alcoholic beverages to the extent that his normal faculties are impaired. It shall be presumed that an applicant or permittee chronically and habitually uses alcoholic beverages to the extent that his normal faculties are impaired if the applicant has been found guilty of, or entered a plea of guilty or nolo contendere to operating a vehicle while intoxicated, or has been admitted, either voluntarily or involuntarily, for treatment as an alcoholic, within the five-year period immediately preceding the date on which the application is submitted, or at any time after the application has been submitted.
L.R.S. 40:1379.3 C.(9)	3	Not have entered a plea of guilty or nolo contendere to or been found guilty of a crime of violence as defined in R.S. 14:2 at the misdemeanor level, unless five years have elapsed since completion of sentence or any other conditions set by the court have been fulfilled, or unless the conviction was set aside and the prosecution dismissed, prior to the date on which the application is submitted.
L.R.S. 40:1379.3 C.(10)	43	Not have been convicted of, have entered a plea of guilty or nolo contendere to, or not be charged under indictment or a bill of information for any crime of violence or any crime punishable by imprisonment for a term of one year or greater.
L.R.S. 40:1379.3 C.(11)	4	Not be a fugitive from justice.

L.R.S. 40:1379.3 C.(12)	1	Not be an unlawful user of, or addicted to, marijuana, depressants, stimulants, or narcotic drugs.
